#### **Inhalation:**

### 6. Accidental Release Measures

## 7. Handling and Storage

Keep in a tightly closed container, stored in a cool, dry, ventilated area. Protect against physical damage. ## 8. Exposure Controls/Personal Protection

### **Ventilation System:**
